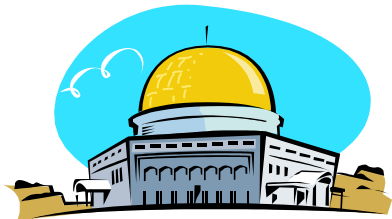

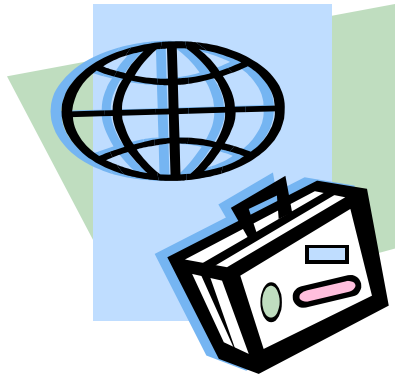

## Guidelines

1. Each year, the Committee on Ministry, through its Clergy Care subcommittee, will award not more than 2 scholarships.
2. Those eligible: ministers within Carlisle Presbytery who have been in the ministry for 5 years and not more than 10 years. (For the first year, the time frame may be extended back to February 2004, when the bequest was first received.)
3. No minister shall be eligible to receive more than one grant.
4. The maximum amount available per request is \$1,000.
5. To qualify eligible ministers should make application to the Committee on Ministry indicating what trip they plan to take, the dates of said trip, and the sponsor(s) of said trip.
6. The scholarship will be paid either after the trip (to reimburse) or in advance, but in such a way that if the trip does not occur, the funds are repaid to the Presbytery.
7. To underwrite these trips, the principal and the interest of this bequest will be used until funds are exhausted.
8. If no applications are received in a calendar year, the funds will roll forward, but in any year, only 2 grants will be made.
9. At the November presbytery meeting, the Committee on Ministry will announce grant recipients.
